Six Runs Field Trial Report

After a hiatus of over ten years the Six Runs Field Trial Club was pleased to host a four day trial that offered something for everyone. The Six Runs Field Trial Club, originally formed in the 1980s, hosted both horseback and walking stakes, Open and Amateur, Shooting Dog and All Age venues at its traditional location on the grounds of Come Back Red Setters, owned by Joe & Brenda Edwards of Warsaw North Carolina. These grounds, a bastion of the red setter restoration effort known as the Purest Challenge, are located just south of Clinton North Carolina in the eastern part of the state. This region has long been a haven for bird dog enthusiasts. The grounds at Six Runs provide an ideal venue for that traditional game bird, the bobwhite quail. Six Runs Farms is typical of the habitat in this part of state, consisting of level to gently rolling terrain covered with a combination of crops and lowlands, and broken up with stands of loblolly pine. Six Runs Creek, a fork of the Cohaire River, cuts through the grounds, offering a natural edge and also a safety net for those bigger running dogs to keep them in the pocket. Thanks to the generosity of owner Joe Edwards, the farm was in excellent condition, and was very suitable for the running of both Shooting Dog and All Age stakes. The field trial community is grateful to Joe and Brenda Edwards for their willingness to open their private training grounds to the field trial community.

This trial could not have been conducted without the help of many friends and neighbors who lent a helping hand during the long weekend. Joe's wife Brenda outdid herself with a menu that would rival any restaurant! Friday night we were served fresh flounder, as well as steamed oysters in the shell. Saturday Brenda served charcoal-broasted chicken with all the trimmings. Sunday was "leftover day" with oysters, chicken, potato salad, green beans, boiled potatoes, and pumpkin or rhubarb pie. No one went away hungry! Brenda was assisted in the kitchen by Mary Boser, neighbor Becky Todd, and east coast resident Kay Graves; these

ladies kept the kitchen humming throughout the trial, serving the constant stream of handlers, visitors, and judges. Joe Edward's good friend Dwight Ingram was the faithful bird planter, and Sean Melvin's sons Jasean, Alijuan, and good friend Jaevion Carter assisted with the many chores that need to be done during a trial; assisting with bird planting, tending to horses, and helping move dogs to the breakaway. It was especially heartening to see these young folks so excited about bird dogs and horses, and we hope they will continue their interest in this great sport.

Judges for the stakes included Ohio native Allen Fazenbaker (Open Derby and Open Shooting Dog) who also reported this trial, Pennsylvanian Roger Boser (Open Walking Shooting Dog and Amateur All Age), Maryland native Tommy Brigman (Open Shooting Dog), North Carolina resident Billie Vaughn (Open Derby, Amateur Derby, and Open Walking Shooting Dog), Sammy Giddens of Faison North Carolina (Amateur Shooting Dog), John Campoli of Illinois (Amateur Derby), and John Outlaw from Warsaw North Carolina (Amateur Shooting Dog and Amateur All Age). The combined experiences of this judicial staff brought an exceptional degree of quality to the trial, and their services were well received and much appreciated. The trial, originally scheduled to run three days, ran into Monday morning due to the number of dogs. The running...

Open Derby

The trial began on Friday morning, with the Open Derby breaking away into cool temperatures and high winds. These winds would increase throughout the day, reaching over 40mph as the temperatures dipped into the freezing mark by nightfall. Fazenbaker & Vaughn marked the red setter Nantucket with the win; this little female handled by Dr. Roger Boser showed a classy forward race and three finds, with high style and maturity on her birds. Close behind was ---Abby, a pointer female handled by Eric Russell. Abby scored two finds and a stop to flush with a nice forward race and aggressive hunting style. Eric rounded out the placements with the pointer male Medlin's Shellshock Hank, who

likewise exhibited excellent bird work with two finds, but was a tad shorter in range.

Open Shooting Dog

The Open Shooting Dog stake was contested by a talent-filled group of dogs, and virtually every brace had dogs worth watching. Taking the blue for Dr. Boser was Justified, a classy red setter male who showed a wide and forward race with 5 finds and a perfect shooting dog performance. Close behind was Come Back Audie, a big running red setter under the handle of Joe Edwards. Audie dug up four birds and a wide race to take second for the Come Back banner. Sean Melvin guided Andretti (Celtic's Spectacular) around with one find and another wide and forward race to take third.

Come Back Patches & Breakstone Patches dug up two finds for her handler Billy Vaughan and showed a pleasing race. Breakstone was lost to judgment.

Celtic's Spectacular & Abby Andretti noted above. Abby scored one find and a back before being picked up.

Come Back Audie & Montana Missy Audie noted above. Missy picked up for an indiscretion on birds.

Come Back Strander & Barney Strander was picked up. Barney carded four finds but was short on race.

Cindy & Come Back Bee Gee Cindy was lost to judgment. Bee Gee scored three finds and a strong race.

Jay & Adella Jay had several finds. Adella was seen under birds and was up.

Justified & Come Back Hightider Justified noted above. Hightider had a strong race but did not find birds.

Open Walking Shooting Dog

Progress at the NRSFTC site in Grand Junction...



If you take a look over here to the left of this story, you'll see the area we once occupied at the Field Trial Hall of Fame Museum. It was roughly about 4 feet wide and we were limited to one tiny bookcase that fit into our spot. Over the vears club members bluow visit the museum & be stunned by our sorry and

limited display. I've received several letters over the years complaining that our site was disappointing and encouraging us to better utilize the space. What could I say? I agreed with them 5000%. When it comes to pointing breeds, the NRSFTC has the two most winning dogs in all of Field Dog Stud Book history— Bearcat and Abra have each amassed greater win records than any other breed to date. Bearcat is 158 and Abra is 156. NO breed of any pointing dog in that museum has bested that record. I've always wished that we could have a running electric banner to brag constantly about the 2 most winning dogs in history. But where could we do it? We had little room and didn't even have access to an electrical outlet. When the Bird Dog Foundation decided to build the new addition, our hopes soared. Space was limited to the amount of money each club could raise. Some clubs have thousands of members— we have less than 100. Still, we said our prayers and appealed to the

claim our area. As you walk into the door of the new addition, the first thing you see is our space. It runs along the right side all the way down until the wall breaks on a turn. Not only did we have a very visible space, but also had we electrical outlet!! At had the last we



potential to put on a display fitting of the beautiful bird dogs we so adore! It couldn't have happened without the generosity of each person who reached out to help! Our first donation came from the Long Island Bird Dog Club who generously donated \$2,025.36 for the construction of three lighted display cabinets. We had an excellent response from the membership too— When you are as small of a group as we are, every cent was important; whether it was five dollars or five hundred— we thank each donor for helping make this happen.

The day we "selected" our area, we had to wait while the larger clubs marked off their sections. We heard them talking about how they intended to hire professional decorators to set up their areas and maximize their space. We didn't have funds or resources for such luxury but we did have some incredible connections and an alternative plan to prepare our spot.

Allen Fazenbaker is associated with Auburn Career Center, a vocational school in Concord Ohio. Auburn offers an exceptional

multi-media program for high school students. We contacted the instructor, Mr. Rodney Kozar, who agreed to assist our club and make it a class project. For the last several months they have worked diligently preparing materials and planning for the NRSFTC space. The students contacted club member Tim Hammons and asked him to make the sign that designates the red setter area. Tim owns Silver Creek Fabrication and is a long time advertiser in *The Flushing Whip*. He created a gorgeous aluminum logo and sign which he sent on to the Bird Dog Museum. Once we arrived in Grand Junction, we painted it RED. In no time at all it was on the wall identifying our area for visitors to see. Thank you Tim Hammons and Auburn Career Center! It just looks awesome!



Allen and I went down to the Museum a few days early to start to put the area together. Craig and Dolly Opel, long time members of the club, were also working on the project and they made arrangements to meet us there. I've corresponded with the Opels over the years but had never met them before. What great folks. They worked shoulder to shoulder with us and turned a huge job into easy business. The time passed quickly as they regaled us with old time historical stories about our club and members. Here we are working:

ahead of time because we were not sure of the measurements until we got the rest of the display in place. We've passed on that information and are now in the process of having the plaque constructed too.

NRSFTC Hall of Fame Inductions Held During Field Trial Hall of Fame Ceremony

The National Red Setter Field Trial Club Hall of Fame gathered in Grand Junction TN, the weekend of February 9th to induct five distinguished persons and one distinguished dog into the NRSFTC Hall of Fame.

We began with the four founding members of our organization. Archer E Church Sr., Allen Bortz, Ralph C Baynard and Herm David were inducted as a class. Over the past few months we managed to locate representatives from each of their families. We were delighted that all had indicated that they would attend. Unfortunately, most lived along the east coast and a sudden ice storm blew in closing airports and cancelling flights. In the end, the only folks who made it to our ceremony were Joanne Bortz, (wife of the late Allen Bortz) and their daughter Mindy Myers. We were delighted to have the opportunity to spend time with Bortz's family and we so appreciated their making the trip. Mrs. Bortz and her daughter drove in from Cincinnati Ohio so they weren't hampered by the eastern storm.

Finding the families of our founders was guite a project over the past few months. I think I might be able to legitimately hang out a shingle as a "private eye" because of my experience researching this project. The four founding club officers did have a couple things in common with one another. They all lived in the eastern US, they ALL enjoyed bird hunting, and they each longed for the kind of capable gun dog their grandfathers had used, the Irish Setter. But, as far as the rest of their backgrounds went- the founding pioneers were as different as night and day. Their ages varied from 53 to 22. Arch Church's had a son that would graduate from the US Naval Academy in 1952— that made him the same age as Herm David! They each did very different kinds of work. Rusty Baynard ran a very popular Mobile Service Station in Dover, Delaware. Allen Bortz was a salesman. Arch Church was a comptroller for a New York publishing firm and Herm David, the young upstart, was a gifted writer. Ned LeGrande sought out these gentlemen and challenged them to join him in what was a formidable and difficult project. He offered to finance it all but asked the group to handle the leadership duties of the "new club." Ned understood he would need a group of people to make up a club committed to the

"field" Irish. He wasn't interested in continuing with a "bench bred" and show fancy mentality in his new organization. The group agreed to work together and initially talked of naming the club the Eastern Irish Setter Field Trial Club. After some heated discussion they decided to call it the National Red Setter Field Club. RED because they knew that to achieve their goal they would need to engage in controversial outcrossing to improve the breed and distance themselves from the show fancy. NATIONAL because they understood that such a project would need a nationwide focus. Ned brought Herm David into the group and paid him to write the Flushing Whip and engender debate and discussion. Herm worked hard to earn his pay. He studied the trial reports to determine who were the best dogs (of all kinds of breeds) in the nation. Once he had the information, he challenged the owners to compete against the new and improved "Red Setters." People really got to talking and paid attention to the results— and, as you might imagine, initially we weren't all that successful. But Ned and his band of merry men continued forward and the hunting qualities of their restored RED setters began to emerge full scale. Our dogs and owners tasted success and everyone got to talking about it.

When one looks at the significant organizations across our land, there is always that initial spark, or seed, or idea that was the impetus to their ultimate success. Many people were talking about the sorry Irish Setter and it's decline as a class bird dog back then—but these four men took it a step further. They stopped talking and DID something.

Their enthusiasm was contagious and as more people became interested they joined our ranks, eager to embrace what Herm David penned as "the Purest Challenge in sportsdom." Do you recognize or remember any of the names? Schollenberger, Hassinger, Schnettler, Flythe, Bean, Moffatt, Crum, Kerans, Peterson, Opel, Watts, Lewis, Zdanczewicz, Edwards, Ober, Boser, Beauchamp...... There are far too many to name them ALL here but in the first fifteen years, our club membership grew to over 200 families— each and every one committed and determined to see the restoration project's success. Now, over 60 years later, we have red setters running across the

country that we can be proud of... they are real deal, true bird dogs in their own right. Who can accurately count all the individuals who (Continued on page 22)

contributed to that goal, a goal set in the minds and hearts of four hunting companions back in 1951? This year we honored the first four who stepped forward and agreed to act. The NRSFTC Futurity is vital for our Success

Many dog organizations have created a breeder's stake or some similar type of competition to support the breeding of BETTER dogs. For example, some groups (such as NAVHDA, the North American Versatile Hunting Dog Association) offer a "Breeder's Award" to encourage best breeding practice. The NAVHDA award is based upon a minimum number of puppies from the litter performing at a required level of working competence.

In the pointing breeds, a futurity is a popular method of supporting the improvement of the breed. The Red Setter Futurity has been in existence since 1973. In the late 1960s our Board of Directors had the foresight to recognize that breed improvement would be enhanced with a competitive breeder's stake. Those Directors placed such high importance on this concept that they insisted that the futurity be run in conjunction with the Red Setter National Championship so that the highest quality judges would be available. Members of the red setter club should keep in mind that the Futurity is not only for breeders. Hunters and field trialers searching for the best quality dog should look at futurity placeholders. Even if an individual doesn't have interest in field trialing, the futurity is an excellent tool to evaluate potential while providing vital feedback to the breeder. This is extremely important to the future improvement of bloodlines. Reputable Red Setter Breeders ALWAYS register their litters with the Futurity and encourage those who purchase puppies to test their young dogs in this way. Breeders, dog owners, and trainers can all play a part in improvement of our breed by working together in this way. Educated breeding programs Honor the Purest Challenge just as our founding pioneers demanded.

Be an educated breeder; evaluate your breeding success through the NRSFTC futurity.

Remember, if you think your dog is worthy enough to breed, you should find an equally suitable mate. Register the litter in the Red Setter Futurity and tell your new puppy owners that you want them to run their dog in its assigned futurity. This year's NRSFTC Futurity will be March 14 to March 17 at the Jim Edgar Wildlife Management Area outside of Chandlerville, IL. There have been 15 litter nominations this year and we salute the breeders who registered those litters. Look at the list: if you have a pup from one of those litters, you SHOULD be running it in the Futurity.






