As a new club running our first field trial, we learned a lot. The support and encouragement that we received from members of the Arkansas Amateur Field Trial Association made the trial a success.

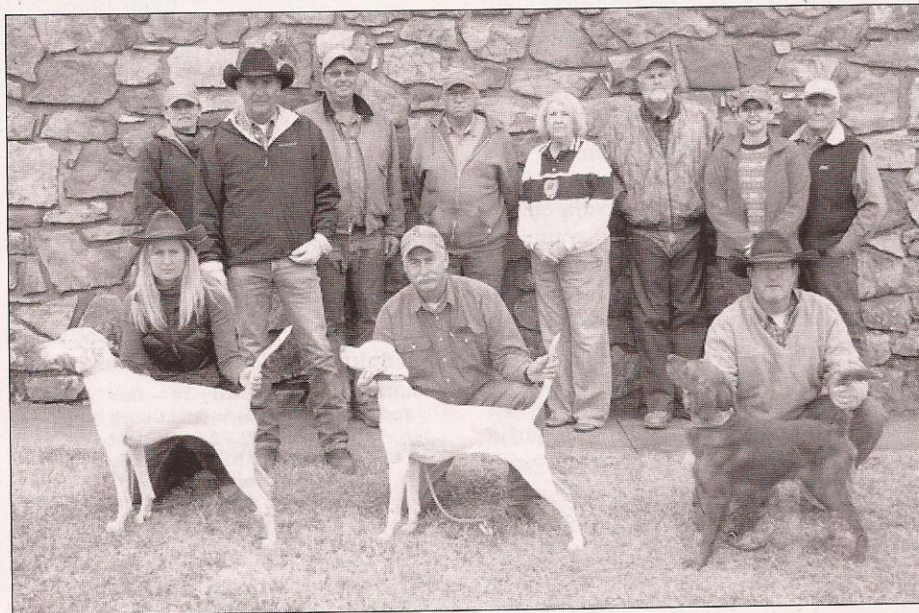

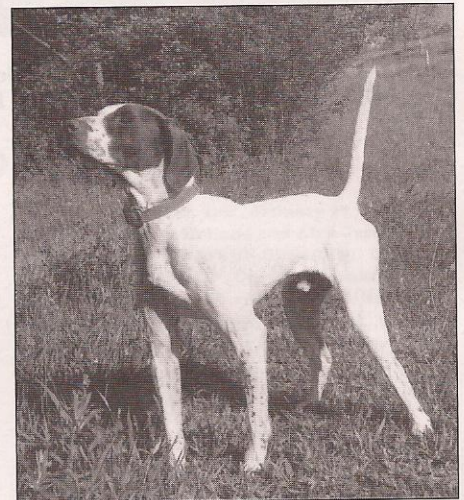
