#### Sportsman Jim Wurtz has died

It is with great sadness that the NRSFTC reports the death of Jim Wurtz who died unexpectedly in Buenos Aires, Argentina last October. Jim was 52 years old. Cause of death was apparently from complications resulting from dental surgery.

Jim was born in Yuba City California, the son of Don and Cloveta Wurtz. He leaves behind his beloved wife, Virginia, son Caelean, his parents, his brother John, sister Stephanie Christopher, his grandmother Claudia Rose plus aunts, uncles, nieces, nephews, other relatives and friends. A Service of Comfort was held on Monday, Oct. 18, 2010 at Faith Lutheran Church, in Fond du Lac.

Jim lived in Wisconsin where he served for 28 years as a Corrections Officer. Upon retiring, Jim traveled to Esquel, Argentina in search of new adventures. Jim was enamored with Argentina countryside and the people who lived there. It was there that he found Virginia, the love of his life. They married and were ultimately blessed with a son. Jim planned to eventually move his family back home but sadly, he died before that ever happened.

Jim had a wide variety of interests. He was an exceptional sportsman who enjoyed hunting and fishing. Jim was also a gifted craftsman, making ornate Damascus knives. But most of all, Jim was a Red Setter aficionado! He loved Red Setters and was fiercely loyal to the breed. His favorite dog, IronFire's Michaeleen Flynn (Mick) enjoyed great success hunting on the Argentina plains with Jim. Jim was a great friend to the NRSFTC. He never missed a chance to tell folks about red setters. His web page was: "dedicated to the working Irish Red Setter, be they hunter or field trial competitor and restoring them to their rightful place in the field." Jim featured Abra and Bearcat on that website, noting that they "were the two winningest dogs, of any breed, in the history of American Field Trials." Jim always said that the "modern Irish Red Setter was a match for any dog, on any bird and in any cover" And he was so right. His enthusiasm for the breed encouraged many folks to "Go Red!" There is no doubt that Jim will be deeply missed. The NRSFTC extends our deepest condolences to his family and to all who knew and loved him. #### NRSFTC Championship and 39<sup>th</sup> National Futurity Code Red takes Championship title, Breakstone is runner up. Firefly's Hot Tip wins Futurity

#### **Championship Winners & Others**

The new Champion, Code Red, is owned by Tim and Kris Hammons, the likeable couple from Berea, KY. They raised "Rusty" and Tim is responsible for his development and training. The 9 year old red male has knocked on the door of this Championship several times before but this time it opened. Code Red put on a good show, scoring three finds in a hard hitting and forward hour. Two of his finds were well out on the limb and Kris is to be commended for her scouting ability. He was high tailed and intent on all three pieces of bird work. Braced with Aiken the pair made us all sit up and take notice. Rusty finished his hour well to the front, using all the ground course three had to offer. Code Red was an obvious choice for winning the title.

The Runner-up Champion emerged in Roger Boser's multi-titled male, Breakstone. He was released at "The Mailbox" on course two. "Stony" scored one excellent find and one attractive, natural back. His race was strong and forward for the most part. He suffered an absence of nearly ten minutes. Breakstone finished the hour forward and going away.

Aiken, owned and handled by Don Beauchamp, was no doubt earning a chunk of the winnings for 55 minutes. He ran a tremendous forward race. Aiken scored three flawless finds and was seen going away at 55 but was not recovered under judgment.

Rocky's Straight Arrow, owned by Brian Gelinas and handled by Don Jones won Runner-up in this stake last year and made a good bid this time. Arrow scored two very nice, stylish finds. He ran a huge race but was a bit rough on handling. He was absent for 16 minutes which detracted from the overall performance but he (Continued on page 9)

finished the hour strong and forward. He was braced with Breakstone.

#### **Championship Running:**

Come Back Gloria (Ed Liermann) & Jericho (Don Beauchamp) Gloria scored four good finds in a steady, well applied hour. She had one unproductive stand. Jericho was the wider of the two in range but was not as consistent in pattern. He scored one find and one back. Both finished the hour forward.

Rocky's Straight Arrow (Don Jones) and Breakstone (Roger Boser) have their performances mentioned above.

Code Red (Tim Hammons) and Aiken (Don Beauchamp) have also been detailed in the Winners & Others section.

Berken of the Snows (Don Jones) & Moonshine Again (Kris Hammons) This was the first brace on Thursday afternoon. Berken ran a kind handling forward race but went birdless. Charlotte scored two finds in a comfortable shooting dog race.

Chaperon (Ross Leonard) & Redstone (Roger Boser)

Chap had two stylish and well mannered finds but two unproductive ended his bid. Redstone scored two pretty finds that were handled perfectly.

Cedar Creek Karma (Ed Liermann) & Flintstone (Ross Leonard)
Thursday's final hour released at the Red Gate. Karma scored one find in a shooting dog range race. Flintstone was lost.

Come Back Silverado (Jason Williams) and Touchstone (Roger Boser) This fast paced brace covered a lot of real estate. Silverado ran a big race. He scored an excellent find at 8 in a feed strip below the cedar grove. Touchstone scored five finds in a shooting dog race. Every find was stylish and mannerly. His first find came at 10 along the ditch. His second find was along the cedar edge approaching the tobacco barn at 16 where he was backed by Silverado. Touchstone's third find was at 38 on the hill top. His

fourth find was on the right just after the road crossing at 42. Silverado was lost before the hour elapsed. Touchstone scored a fifth and final find beyond the shooting range at 51. Touchstone took direction from his handler very well and finished forward.

Jordin (Bonnie Hidalgo) & Come Back Tough (Jason Williams)
Both were forward in application. Jordin carded an unproductive
at 8. She pointed again at 17 with birds well located. She was
high and tight throughout. She continued her forward, shooting
dog pattern until 30 when she came in with an injury and was
picked up. Tough was picked up late in the hour with no bird
contact.

#### 39<sup>th</sup> National Red Setter Futurity

Firefly's Hot Tip, a red and white female Irish setter won the Futurity by showing ability to perform at all age range while finding and pointing game. She was whelped on February 12, 2009 from a litter sired by Aiken and out of Firefly's Last Redcent. Tippy was bred and is owned by Dennis and Bonnie Hidalgo of Brighton, CO. Bonnie handled her to this win.

Justified is a red, male Irish setter; he earned second place in the Futurity. Justified was bred by Rex Cottle out of Come Back Judy when bred to Breakstone in a litter whelped May 24, 2009. Dr. Roger Boser is his owner and handler.

Calypso placed third. This red male is a littermate to Justified. He also is owned and handled by Roger Boser of Seven Valleys, PA

Fourth place was not awarded in this year's renewal of the National Red Setter Futurity.

The National Red Setter Futurity runs each spring following the completion of the National Red Setter Championship. This year it was judged by David Sparks of Berea, KY and Tom Perry of Newnan, GA.

Allen Fazenbaker is the Futurity Secretary. He takes all nominations and produces a record of eligible litters and individual dogs. All is always on hand for the running of the stake to make sure all is played according to Hoyle. All is an excellent Futurity secretary and his efforts are very much appreciated by the NRSFTC members.

The National Red Setter Field Trial Club established Standards for its Futurity in 1983 and revised them in 2002. The following is quoted directly from those revised standards. As in the case of all American Field trials, when no stake designation is noted, the stake is considered to be an All Age stake.

#### National Red Setter Futurity Judging Standards

The Futurity shall be run in the spring of each year over preferential bob-white quail territory.

Placed dogs shall display an intense desire to find birds, a keen nose to detect the presence of game and ability to locate it quickly and accurately by body scent. Placed dogs must show staunchness, positiveness and style on point but not necessarily be steady to wing and shot. (Staunchness should mean positiveness on point; where the dog establishes point but not necessarily where the handler can dismount, flush and fire before the dog moves on.)

Placed dogs must show determination under adverse conditions and intelligent adjustment to terrain and cover, the ability to hunt independently with speed and proven endurance. Placed dogs shall adjust range to cover and character of the country and to show desire to please the handler. The event shall be run under standards established by the American Field and Field Dog Stud Book, the Amateur Field Trial Clubs of America and the National Red Setter Futurity.

The futurity shall be run, if necessary in order to name a winner under these standards, in two series. The first series "The Flushing Whip: Official Publication of the Red Setter Foundation, Ltd. serving the National Red Setter Foundation of the Red Setter Foun

shall be run over continuous multiple courses, each brace to be run for thirty (30) minutes unless earlier ordered up. Said continuous multiple courses shall contain native birds plus liberated quail which shall be released in coveys in such manner as to simulate natural conditions as much as possible. The numbers of liberated quail shall be decided by the Futurity Secretary, the Club President and the Trial Chairman in consultation with the Area Manager. If four dogs, which in the sole discretion of the judges are otherwise capable of placement have not pointed birds at the conclusion of the First Series. A Second Series shall be run, each brace being run for thirty (30) minutes unless earlier ordered up on a single course with liberated birds released in the manner previously indicated of sufficient quantity to permit adequate opportunities to point. The number of dogs called back for a Second Series shall be at the sole discretion of the judges and may be augmented by the judges if necessary in order to place four dogs that have pointed.

All dogs in each series shall be announced as "called back" in the order in which the judges would place them if they shall adequately demonstrate their ability to point birds by doing so. The callback shall be conducted from horseback. Judges may not, except with the concurrence of the Futurity Secretary or his designee, who may seek advice from the Board of Directors of the National Red Setter Field Trial Club, deviate from these standards. Dogs with bird contact must be fired over with a blank cartridge gun of not less than cal. 32.

The above listed standards were reviewed by the Judges in consultation with Futurity Secretary Al Fazenbaker prior to the start of the stake on Friday morning. Judges were given a copy of the rules to carry with them.

There were fifteen litters nominated for the 39<sup>th</sup> running of the

Red Setter Futurity. Nine different sires were utilized. Three breeders produced three litters each. The six remaining litters were bred by individual breeders. The top producing breeders were Andy Agnew, Roger Boser and Stuart White. The sires leading the nominations with three litters each were Altamuskin Leftover, Breakstone and Buster Brown. The remaining sires of this year's futurity nominated litters were Aiken, Chaparral, Come Back Audie, Jericho, Rocklane's Pete and Silver Creek Solution. Actual entries came from litters with the following sires: Aiken, 2 entries from 1 litter; Breakstone, 2 entries from 2 litters; Chaparral, 1 entry, Come Back Audie, 1 entry; Jericho,1 entry; Rocklane's Pete, 1 entry; Silver Creek Solution,1 entry and Buster Brown, 1 entry.

#### **Futurity Winners & Others**

Firefly's Hot Tip was predominantly forward and hunted the edges with good speed at the desired range to win this stake. She pointed on the cedar edge before the tobacco barn; showing high style with derby manners. Her bracemate came past after Tippy had established point and both dogs moved into the cover, where she pointed again.

Justified ran a nice race with good pattern but with less range than the winner. He scored one very nice, finished find.

Calypso ran a medium ranging race, staying forward consistently. He pointed once but it was not productive. His performance gained him entry into the call back to demonstrate pointing ability. In the call back which is done from horseback on planted quail, he found and pointed his game with ease.

Rising Fawn Alafair belongs to Ross Leonard of Cloudland, GA who was her handler. Ross won this Futurity in 2009 (Come Back Buck) and 2010 (Flintstone). Allie was bred by Don Beauchamp of Cheney, KS. She is from the mating of Chaparral and Sunset

Silk. Allie ran a very nice, consistently forward race. She had no bird contact but she was named to the call back by virtue of her ground effort. Unfortunately for Allie she failed to point her game in the call back and thus was ineligible for placement.

None of the other entries were deemed suitable for call back by judges David Sparks and Tom Perry. They felt that no other dogs had the ground effort that meets the standard of this Futurity. While the National Red Setter Field Trial Club hopes to place four dogs in each Futurity and therefore created the call back provision; it intends that the standard be upheld when doing so.

#### **Futurity Running:**

Calypso (Roger Boser) & Firefly's Little Dickens (Bonnie Hidalgo) Calypso is mentioned above. Jimmy ran a big race but was not keen on handling. His handler opted to pick him up after he failed to back.

Firefly's Hot Tip (Bonnie Hidalgo) & CC Tullamore Dew (Al Fazenbaker) Tippy is mentioned above. Dewey made a good hunting effort but lacked the desired range. Dewey came upon Tippy on point and moved into the cover where he established point briefly.

Zan Sett Jay (Randy Sanderson) & Justified (Roger Boser)

Jay ran a close race with no bird contact. Justified is listed above.

Rising Fawn Alafair (Ross Leonard) & Red Rock (Tim Hammons)

Allie was worthy of call back and her efforts are given under

Futurity Winners & Others. Red Rock was lost.

Natural Red (Bill Aughenbaugh) & Rocklane's Rosie (Brian Gelinas) These dogs handled kindly at medium range.

#### Open All Age

This stake ran on a rainy Saturday morning with Tom Perry and David Sparks in the judicial saddles. Ten dogs were entered and run.

First place went to Breakstone owned and handled by Roger Boser. He had two finds in a big race.

Second Place went to Come Back Silverado with one very nice find and a big race.

Come Back Tough was third with a nice race and one stylish find.

#### **Open Shooting Dog**

This stake ran on Saturday afternoon with the rain continuing. Judges Sparks and Perry watched while all braces were run and then chose their winners.

In first place was Come Back Silverado owned by Rupert Colmore of Duck River, TN and handled by Jason Williams. Silver ran an excellent race with precise bird work.

**Redstone** was second for owner/handler Dr. Roger Boser. Dolly ran a fine race with perfect bird work.

**Come Back Tough** was third with a good race and nice bird work. Tuffy was handled by Jason Williams for owner Rupert Colmore.

#### **Open Puppy**

This stake ran on Sunday morning and concluded the trial. Tim and Kris Hammons were the judges. It was chilly and overcast but dry.

Altamuskin Jake won the Puppy stake with a nice forward race. Jake belongs to Andy Agnew of Knoxville, TN who handled him.

In second place was **Altamuskin John Henry** also owned and handled by Andy Agnew. John ran a predominantly forward race at nice range and was quite similar in ability to the winner who is his littermate...

#### NRSFTC Walking Stakes / NBHA Stakes

This year, for the first time, the Walking Stakes were sanctioned by the National Bird Hunter's Association and were open to other breeds in addition to the Irish Setters. This was done in an attempt to give more feasibility for a class walking shooting dog stake at this event. There were sixteen entries in the One hour, Jack Carter Walking Shooting Dog Classic. The Open Walking Derby drew eight dogs.

The National Red Setter Club has attempted to run a quality Walking Shooting Dog Classic for its members whose interests lie in Walking stakes. The idea was to one day have a quality stake that was befitting a Championship title. Unfortunately there wasn't enough consistent support to make that happen. Last fall the Red Setter board of directors was asked for permission to open the stake to all breeds and to have it sanctioned by the NBHA. The board in an effort to satisfy the needs and desires of this faction of members granted approval on a trial basis. The Jack Carter Walking Shooting Dog Classic, a one hour stake came into existence and the Walking Derby was also opened to all pointing breeds.

Judges for both walking stakes were Ken Taff of Georgetown, KY and Jack Flynn of Asbury, NJ. The Club is appreciative of their efforts!

#### Open Walking Derby

The walking derby stake was run on Friday morning March 4 and had eight entries. Weather conditions were good, with temperatures in the 50s, breezy, and no rain. First place went to Sliced Bread, a pointer female, coupled a driving forward race with a quail find. She is owned and handled by Gunnar Graven of Louisville, KY.

**Leonard's Strongbow** was second with a productive forward race with two quail finds. This red setter male puppy is owned and handled by Al Fazenbaker.

Vitali's Grouseringer placed third with a medium forward race and two finds. This English setter male is owned and handled by Gary Vitali.

#### **Jack Carter Walking Shooting Dog Classic**

Named as a memorial to an old time and much respected member of the NRSFTC, this stake was conducted on Saturday in a cold and driving rain. Conditions were unpleasant and challenging for man and beast. The woodcock migration was in full force; multiple woodcock were contacted during the stake, and eight dogs were picked up due to improper handling of the wild birds.

In First place was **Foshee's Tuff**, pointer male owned and handled by Roger Foshee of Afton, TN. "Tuff" had a strong, forward race with two quail finds.

Meteu Medicine Man was second with a nice forward race, two quail finds and one barren stand. This red setter male was handled by his owner, Allen Fazenbaker.

Prickly Ash Annie, an English setter female was third with two finds on quail. Annie is owned by Kenny and Sam Purvis of Owensville, KY and was handled by Kenny.

#### Sidelights at the Red Setter Nationals

Tim Hammons did a fine job as trial chairman. Each morning he was the first to arrive and planted birds on all three courses with the help of Charlie Turner. Tim also was on hand during every brace to marshal.

The dog wagon duties were handled by several different people so please excuse me if I omit anyone! Credit for that during the three and a half days of the trial goes to Brian Gelinas, Rupert Colmore, Stan Zdanczewicz and Jim Ashby.







#### **Rules for all NRSFTC Awards**

#### Puppy of the Year

Only Puppy wins count toward point total (Puppy stakes; from January 1st to June 30th in each year for dogs whelped on or after Jan. 1 of the year preceding and from July 1st to Dec. 31st in each year for dogs whelped on or after June 1st of the year preceding.) Wins recorded from F.D.S.B. recognized trials only.

Points to be compiled from July 1st to June 30<sup>th</sup> the following year. Chart that explains point calibration follows the Puppy Derby Section. Report of win must be made within 30 days of win. It is the responsibility of the owner to report wins.

Owner must be NRSFTC member in good standing.

Report of top 10 dogs to be made semi-monthly in *The Flushing Whip*.

Winners of the Puppy of the Year Award will be announced as soon as determined after June 30th of each year. The Puppy Award will be presented at the NRSFTC Fall Championship banquet. Permanent trophies to be retained by the owners will accompany the rotating trophy. All placements must be verified by publication in the American Field before becoming official. Trials restricted to only AKC registered dogs are not accepted. Information on reporting your wins will be listed at end of Derby section on the following page.

#### Derby of the Year

Only Derby wins count toward point total (Derby stakes: from July 1st through Dec. 31st in each year for dogs whelped on or after Jan. 1 of the year preceding and from July 1st through June30th in each year for dogs whelped on or after Jan. 1<sup>st</sup> of the second year preceding.) Wins recorded from F.D.S.B. recognized trials only.

Points to be compiled from July 1st to June 30th the following year. Report of win must be made within 30 days of win. It is the responsibility of the owner to report wins. Owner must be NRSFTC member in good standing.

The Derby Awards Secretary will report the top derby dogs and they will be listed semi-monthly in *The Flushing Whip*.

All placements will be verified by the American Field. Trials restricted to only AKC registered dogs are not accepted.

#### **Duke Award**

In order to qualify for the Duke award, you must earn points by competing in the following type of stakes: Top Shooting Dog Award (published in the *American Field* in August each year.) National Amateur Shooting Dog Invitational (listed by eligible clubs in their individual trial ads.) Points will be awarded for trials beginning in the fall (after July 1st.) through the following spring (June 30th.).

Qualifying wins to be reported by the owner to the awards secretary within thirty days. It is the owner's responsibility to report those wins. The secretary will verify the wins through the *American Field*.

The Duke Trophy can only be won by a dog owned by a member of the National Red Setter Field Trial Club in both calendar years of the award period. (Member calendar year 2011 for fall 2011, member calendar year 2012 for spring 2012)

Don Beauchamp, the award secretary will report the top dogs in The Flushing Whip.

Calibration and scoring of points will be explained on a chart directly following the rules for the Duke, Le Grande and High Performance Awards.

This year Purina is again sponsoring the Top Shooting Dog Award events that will be qualifying trials in addition to the designated points trials for the Amateur Shooting Dog Invitational. Check The American Field during August for a list of Purina Events which do apply to this year's Duke Award. Open Shooting Dog points trials and Amateur Shooting Dog Invitational trials listed by eligible clubs in their individual ads also count toward this award.

Wins must be reported to the award secretary within 30 days after the trial. It is the owners responsibility to report wins.

Owners must be a member in good standing of the NRSFTC




