Middle Atlantic Region 2 Annual Field Trial Clubs of America held a meeting June 18 at Shaukweiler's Hotel in Fogelsville, Pa. at which time new officers were to be elected and a date and place for the Region Championship were to be decided upon for this fall. John Hoffert will be advising us about this.

Dr. Van Wye made the following note after viewing the Heart of American Annual All-Breed Dog show which we should think about: "Frankly, I found it alarming. There was only two English Setters that were not "cow-hocked" either with the classic "X" shape or the frequently seen "Y" shape. I believe the "Y" shape is due, in part, to the lack of conditioning. Roading these dogs would really improve them. The Irish were in much better shape. The thing that alarmed me about the Irish was the severe angulation of their hind legs. They are beginning to move like a German shephard. We know that "cow-hocked" legs are seen more often with severely angulated haind legs, although this was not true this year. More fright ening is the fact that Hip Dysplasia is associated with severely angulated legs. I will have more on this next month in the article. "Pedigree Percentages and Heredity"." And here are a few points made: I have always resented figuring the percentages of pedigrees because it does not take into account the prepotency of the animals involved, major dominant genes and recessive genes. Although it does not take in these aspects in planning our breeding, it does act as a safety warning and helps to clarify our main blood lines. We know linebreeding, and its more potent forms of family breeding and inbreeding, intensifies both the good and the bad inheritance. Through years of experience, geticists have found that as long as the line breeding is not over 20%, there is rarely any trouble. This holds true for all forms of animal life. The offspring is the 100% result (50% each from Father & mother) (25% grandparents & 121% great grandparents) There are 16 great great grandparents so their worth would be 61%, You can see that the latter would have little thoretical influence unless there was a very strong prepotent one involved. Geneticists are aware of a law called "The Drag of the Breed". This is a tendency of offspring to be average. We must have prepotency in our dogs or the Drag of the Breed will literally drag our dogs down to mediocrity. With no background in his genetical he is not able to instill his excellence in his offspring. Selective line breeding in its tighter forms is the only one method to overcome this, Dr. Van Wye, believes. This is the way he feels we can improve our Red Setters, just be aware of the calculated risks.
