handler. The dogs are expected to show forward searching for any piece of cover that may hold a bird. Not all of the country is big, the hills and pole timber lead to cuts and thickets of pine, black birch, blueberries and beech. Upon reaching the cover hard driving canines are expected to hunt briskly, make their mark, or move on to the next cover for another look. The birds are there but not easily presenting, making the task ever more difficult.

Inclement weather plays a key role with the birds as well. This renewal proved no different, starting off with sunny and pleasant weather which time and again bodes ill for bird-finding. But before long Mother Nature took a turn for the worse and the birds presented themselves. Clouds rolled in the third day and rain arrived the fourth with spells of high winds and drenching downpours. Then again Mother Nature changed direction and the back side of the storm provided opportunities on grouse again.

THE WINNERS

Due to the lapses between braces with definitive bird work, the reporter did not have a lot of notes to work with and chose to bypass a brace-by-brace review of the trial. An account of the winning performances follows.]

Thunderhills Zeus rose to the occasion on Loleta No. 4 just before the

storm. I think he may have stirred it up! His pace never let down across the hills and through the pole timber. Upon his first intake of cover Zeus went to work pointing at 17 after a brief bit of confusion with his bracemate's bell. With a bird quickly flushed and all in order, handler Brenneman collared his charge away only to turn him loose into a find 10 yards from his restart! The dog was again collared away and released and his gait opened hard and exciting but yet another bird froze him into granite a few short moments later. Again all was in order and consecutive finds were in the book at 17, 20 and 23. Off for another restart and into the pole timber the multiple champion began putting on a show. The open pole timber of Loleta course No. 4 served Zeus well as he filled up the course, as that of a horseback dog, handling effortlessly while going to the limits. Zeus hit the cut on the back corner of the course at 36 and carded his fourth class forward find at 40 with a grouse thundering straight up for the gallery! Nothing was going to stop him now and his veteran handler knew it. Brenneman let Zeus fly through the open country and into the blueberry thickets ending this course as he finished far reaching and forward. At time Zeus was gathered up with little effort coming into the handler and almost seeming to say, "Top that one boys."

After the rain and the storm front blew through, Pine Straw Katydid earned runner-up for first time handler Mike Reeves. Running in the final brace of the stake she hit course No. 1 on Lamonaville with a hard driving gait and hunted consistently her entire hour, although not as consistently forward as the winner. At 35 she made a quick move to the left of course around her bracemate which was making game to the right. About 70 yards to the front of her bracemate's action she quickly made game and smartly pinned a grouse just off the path with all in order. Taken on she continued her hard drive, lateral and clinging a few times but coming on her own. As the course expired time still remained and the judges instructed both handlers to head to the left into the pine stands between courses No. 1 and No. 2. As time was called Mr. Reeves found Katy with a pair of grouse pinned under what must have been the very last pine tree on this patch. Proving she never gave up she surely left her owner with a smile.

OPEN STAKES

The Open stakes were under the watchful eyes of judges Steve Gruber and Connie Riley. Open Shooting Dog winner Peace Dale Scooter justly

deserved his placement for Gene Thomas. There is an old saying: "You've got to go out on a limb sometimes because that's where the fruit is."

Scooter was certainly out there hanging and looking for fruit. Hanging on a limb is always exciting but when you actually grab the fruit without falling, it is even better. This setter knocked the second and third place dogs down a notch by the time he was finished. He started strong, had a find early, moving from the early bottom of the course to the bean field where he stylishly backed his bracemate. Moving on, he had his second find at the quarter mark, all in good order. At the distant midpoint of the course he had No. 3. On release he showed a strong, forward, edgegrabbing move that finally brought him to the three-quarter point of the course and his last find which was handled in fine order.

White Spider, second, had her first find at the bean field. Her second find came at the back field hedgerow, everything in order. Third was Archers Black Powder, again with Gene Thomas at the helm. "Kip" had his first find at the course bottom just after the breakaway. His second find came in the large hay field at the center of the course and was quickly followed by another find along the woods edge on his journey to the far end of the course. His bird work was flawless. His last find came on the back course in the large hav field.

The Open Derby winner was The Thrill is Gone, pointer female which displayed a great forward race and four
