A Devoted Friend of the NRSFTC has died: God Bless Wilson Dunn 6-5-18 to 11-24-11

LEROY WILSON DUNN, 93, longtime resident of Grand Junction, Tenn., died Thanksgiving evening, November 24th. Twelve years earlier, Wilson's beloved dog, "Dunn's Fearless Bud" passed over into the heavenly fields on November 24th. Almost makes you wonder if Wilson whispered a promise to Bud right before the dog died: "I'll meet you in Heaven's best field on some Nov 24th in the future." It's hard to say but I'm certain Bud was eagerly waiting for his Master's arrival last November 24th— and I imagine Miss Polly was right there at his side. Mr. David Fletcher wrote the following eulogy which appeared in the American Field right after Wilson's death:

"The Dunn name has been familiar to bird dog field trial fans for more than fifty years. In 1953 the enterprising hardware merchant opened his store in Grand Junction, and over the ensuing five decades Dunn's became a household name in the sporting dog community, and the business eventually became a leading mail order entity.

Mr. Dunn attributed a great measure of his early success to the late William F. Brown, editor of The American Field, who suggested to him to advertise in The American Field. He did so, placing his name before the public and his business "took off." Wilson Dunn was born in 1918 in nearby Rossville, Tenn. His father and mother had two other children, but they died as infants. Wilson attended grammar school in Rossville, and graduated from Moscow (Tenn.) High School in 1936. Four years later, December, 1940, he married Polly Snelling, who preceded

him death in January, 2009.

Wilson and Polly had two daughters, Linda (Sam) Jennings and Nancy (Rodney) Chamblee. He had xx grandchildren and xx great grandchildren.

I met Wilson Dunn in 1967 at Henry Berol's Di-Lane Plantation near Waynesboro, Ga. He came to the Georgia Quail Championship with his pickup truck loaded with dog collars, leads, roading harnesses, bridles and many items for dog and horse owners, field trialers, dog handlers and the like.

Wilson Dunn's energy and enthusiasm as a salesman was unmatched. He brought his goods to local field trials, and his name became associated with quality merchandise that he stood behind. His store in Grand Junction, especially when trials were held in that locale, was a mecca for field trial and bird dog folks and where one could be almost assured of meeting other likeminded sporting dog fanciers.

As his business expanded, Wilson devoted a portion of his large retail store to a modest museum where field trial and bird dog memorabilia was put on display, an added treat for his customers.

In 1984 he sold his business, but the bird dog memorabilia was not part of the transaction. In the late 1980s, Wilson and Gary Lockee came to Chicago to discuss what they felt was a need for the sport — a foundation that would serve the sport as the umbrella entity for a sporting dog museum and the Field Trial Hall of Fame that had been unsuccessfully initiated in the early 1970s.

They had a parcel of land, and some monies were still available from the initial Hall of Fame fundraising in the 1970s. Through the unstinting efforts (both time and resources) of Wilson Dunn and Gary Lockee, who had moved to West Tennessee, the Bird Dog Foundation was established, and today boasts a beautiful

and impressive sporting dog center in Grand Junction.

Wilson Dunn's early association with bird dogs began with Brittanys, then setters in the 1970s, and eventually pointers. As you enter Grand Junction from the west there is a sign on the side of the roadway that hails the town as the home of "Dunn's Fearless Bud — Winner of the 1990 National Championship." Bud's win of the Grand Junction Classic, handled by Randy Patterson, was a high point in Wilson Dunn's field trial career. Bud also won the Purina Award for that field trial season. A second "high point" occurred in 1996 when Wilson was elected to the Field Trial Hall of Fame.

Wilson Dunn, Gary Lockee and John S. O'Neall, Jr. were the prime movers of establishing the Bird Dog Foundation in Grand Junction. Wilson was involved with purchasing the land, and he served the Foundation as a director. He was a great promoter of the Foundation and the Bird Dog Museum and worked assiduously to ensure its success. He was very proud of his town, Grand Junction, and very proud of the National Championship at nearby Ames Plantation.

Wilson patronized several dog trainers and was a patron of the field trial sport for decades. His wife Polly was a wonderful and gracious lady, taking part in almost everything that was going on in Grand Junction.

I will always remember Wilson as a great field trial man, a gifted salesman, a gracious host and a Southern gentleman. Octogenarian W. C. Kirk, who won the National Championship with Johnny Crockett (1970), and I communicated recently remembering Wilson and our tribute is given with a heavy heart and all sincerity."

The death of Wilson Dunn causes great sadness to the Field Trial community, and to all who knew and loved this man. Still, one has to imagine the great celebration in heaven when Wilson was reunited with those he so cherished. I can picture them now, Polly and Wilson galloping behind Bud as he treats them to one perfect find after another. Ride on the wind, Wilson! Go in Peace. May your coveys fly far and fast!

NRSFTC Shooting Dog Championships

Redstone and Breakstone dominate

Redstone captured the title of National Red Setter Open Shooting Dog Champion for 2011. The three year old female is owned and handled by Dr. Roger Boser of Seven Valleys, PA. Breakstone, sire and kennel mate to Redstone, was named Runner-up Champion for Roger Boser. Thirteen top quality Irish Setters competed for the title.

In the National Red Setter Amateur Shooting Dog Championship, again with a Baker's dozen entered, the Boser stars reversed their positions with Breakstone emerging on top and Redstone settling for Runner-up.

The trial was conducted over the wonderful Grovespring, MO venue of the Field Trial Sportsmen's Association beginning on November 3. The three, one hour courses at Grovespring are among the finest in the country. The Field Trial Sportsmen's Association's practice of planting feed strips along all of the edges and scattering feed in those strips keeps the birds on the edges. The birds were found for the most part in large coveys that flushed readily, hanging out in general vicinities but not in predictable exact locations. The grounds were in superb condition and birds were plentiful; fourteen large coveys were moved on the first day of running and good numbers were seen throughout the trial. These pre-released birds act and fly like wild birds making them a challenge and a thrill to discover.

The Drawing was held on the eve of the trial at the Clubhouse on the grounds and was well attended. Entries held steady with the 2010 totals but were down from the norm for the second consecutive year. Unfortunately this is a sign of the times; when the economy turns around the entries will no doubt increase once more. Thirteen were drawn and run in each of the Championship stakes, with another seven entries in the Red Setter Open Derby and six in the Red Setter Open All Age.

In the Derby, the winner was Fidler's Firefly King Louie, a male owned and handled by Stephanie Fidler of Oak Grove, MO. Second place went to Kindle, a female owned by Bonnie & Dennis Hidalgo of Brighton, CO and handled by Bonnie. Rendition, a male owned by Roger Boser was named to third.

Come Back Silverado won the Red Setter Open All Age for under

NRS Open Shooting Dog Championship Winners & Others

The 2011 National Red Setter Open Shooting Dog Champion, Redstone appeared as a bye dog on course one, Friday morning. She ran a fantastic forward race, taking the edges and running them all to their proper conclusion. She handled Davis bottom like a pro before dropping out of sight to the front. She was found at the creek crossing, locked up tight on a covey with all in order at 28. From beginning to end, her hour was an exciting one to watch. She finished her hour at the end of Little Vine loop having covered an amazing amount of ground in her search for game. Roger Boser had her fine tuned and Redstone did not disappoint! Redstone was whelped in February of 2008 in a litter sired by Breakstone and out of the dam, Applebee. Redstone counts among her prior placements, 2nd in the spring 2010 National Red Setter Futurity and Runnerup in the National Red Setter Shooting Dog Championship in the fall of 2010

Breakstone, the Runner-up Champion drew the third brace of the stake and was released at the clubhouse gate. He was forward up the hill at the start. He was absent briefly on the west end of the loop but showed forward in Horse Corral bottom. Breakstone continued with an attractive forward

hour; he was impressive as he rimmed field edges with a kind handle. He pointed intently near the cemetery at 38, Boser had to go under the fence to put up his birds but it ended with all in good order. At 45, Breakstone pointed again, this was on the way up the ridge but was not productive. Stony continued forward until time was called although his pace was somewhat slower than when the hour had begun. Breakstone has become a household word in the circuits he travels. His list of wins is immense and he has dominated the National Red Setter scene these past few years. His rapport with his owner and handler Roger Boser is inspiring.

Jordin was carried on the judge's card until Redstone ran in the final hour. Her brace was turned loose just off Apple Tree hill on Thursday afternoon. Jordin backed with style and manners at 7 while her bracemate was taken up. Jordin's first find was toward the far end of Little Vine loop, she showed excellent style and manners. On the right edge of the cornfield at 21, she notched her second flawless Rounding the corner into Sycamore bottom, she stacked up nicely on the left edge; standing high and tight for the flush of the covey. Aiken (Beauchamp) was braced with Cedar Creek Ginger Snap (Liermann) Aiken showed forward a few times to the first creek crossing before becoming lost. Ginger showed fast and forward; she was kind handling. Ginger pointed below Horse killer but went with the flush.

She was absent by the time the course reached the gates to Sycamore but returned to the front at Davis bottom and continued forward. Patina had an unproductive at 29 in Davis bottom and was in general not pleasing her handler who opted to pick up.

Jordin (B. Hidalgo) and Jericho (Beauchamp) were released near Little Vine road. Jordin pointed a covey at 30 seconds, handling the situation very nicely. Jericho went up the Little Vine Hill and pointed on the right edge at 2. Unfortunately, he wasn't so lucky and was taken up. As I sit here at my computer with thorns still emerging from my skin this next part is brought "sharply" into focus! Jordin was on point on the right edge at 8 but even a determined flush in a briar patch netted no game and she went on with an unproductive. 

Tribute to a Dog By George G. Vest

George Graham Vest (1830-1904) served as U.S. Senator from Missouri from 1879 to 1903 and became one of the leading orators and debaters of his time. This delightful speech is from an earlier period in his life when he practiced law in a small Missouri town. It was given in court while representing a man who sued another for the killing of his dog, a foxhound named Drum. During the trial, Vest ignored the testimony, and when his turn came to present a summation to the jury, he made the following speech and won the case. Drum's owner was Charles Burden. He sued and was asking 200 dollars. After only a few moments discussion, the jury awarded Mr. Burden 500 dollars and their deepest sympathy. "Gentlemen of the Jury: The best friend a man has in the world may turn against him and become his enemy. His son or daughter that he has reared with loving care may prove ungrateful. Those who are nearest and dearest to us, those whom we trust with our happiness and our good name may become traitors to their faith. The money that a man has, he may lose. It flies away from him, perhaps when he needs it most. A man's reputation may be sacrificed in a moment of ill-considered action. The people who are prone to fall on their knees to do us honor when success is with us, may be the first to throw the stone of malice when failure settles its cloud upon our heads.

The one absolutely unselfish friend that man can have in this selfish world, the one that never deserts him, the one that never proves ungrateful or treacherous is his dog. A man's

dog stands by him in prosperity and in poverty, in health and in sickness. He will sleep on the cold ground, where the wintry winds blow and the snow drives fiercely, if only he may be near his master's side. He will kiss the hand that has no food to offer. He will lick the wounds and sores that come in encounters with the roughness of the world. He guards the sleep of his pauper master as if he were a prince. When all other friends desert, he remains. When riches take wings, and reputation falls to pieces, he is as constant in his love as the

sun in its journey through the eheavens. If fortune drives the master forth, as an outcast in the world, friendless and



homeless, the faithful dog asks no higher privilege than that of accompanying him, to guard him against danger, to fight against his enemies. And when the last scene of all comes, and death takes his master in its embrace and his body is laid away in the cold ground, no matter if all other friends pursue their way, there by the graveside will the noble dog be found, his head between his paws, his eyes sad, but open in alert watchfulness, faithful and true even in death."

Introducing Tom Robson and his best pup, Bailey. I asked Tom to write a few words about himself and his interest in our club. Take it away Tom:

"I am an Architect, have had my own firm since 1984, doing mostly Multifamily housing, Hotels and Commercial work in New Mexico. Texas. Colorado and Arizona. My wife, Judy, was a stay at home mom while my two sons were growing up....now she takes care of me, waiting for ME to grow up, I suppose! My sons are out on there own and I am trying to be



semi-retired. Two of my closest hunting and fishing buddies are Henry (who owns a winery in New Mexico) and Farrell (who owns a farm in Kansas.) They both have Springer Spaniels but don't hold that against them, because Farrell's Kansas connection is how I came across Bailey!

Bailey stole my heart in November of 2010 three months old and ready to take on the world. Bailey's sire, Jericho is owned by Don Beauchamp and her dam is Mattie's Blue Darter owned by Mark Workman. I was looking for a bird dog when I found the NRSFTC web site. I had owned a red setter, named Colleen, years ago and really wasn't going to buy another pup that wasn't a Red

Setter. When Colleen died in 1987, I did try other breeds. I hunted behind a Brittany, but she couldn't find a bird if it bit her on the nose, a Lab and finally a Springer, who was a good flushing dog but, you know there is something special about a pointing dog.

While surfing the internet I discovered the NRSFTC web site and Don Beauchamp's Pine Hollow Kennel in Cheney, Kansas, which was not far from Farrell's farm! Right there on the Pine Hollow home page was a picture of Buddwing. I called Don right away, and we got to talking; I told him why I was looking for a red setter and he told me he had a litter and there were three females left— although Don was keeping one of them for himself. What clinched the deal was the fact that the dam of the litter was a direct, although many times removed, descendent of Buddwing. My previous dog, Colleen, had been one of his puppies— I'd purchased her in the winter of 1974-75, talk about a small world! It just so happened that David Garrett campaigned Buddwing in the Southwest Field Trial Circuit out of Corrales, New Mexico; and that my friends, is how the circle was completed.

I took her hunting last winter or should I say, she hunted pretty much wherever she wanted, as hunting dog pups are prone to do. She did get a snoot full of quail on occasion and actually did some retrieving. This year was her first official season so we went back to Kansas to hunt the farm for quail. She did amazingly well, in two morning hunts we killed 12 quail over her which she retrieved to hand, just like a real bird dog. She pointed many more than those twelve but, truth be told our shooting wasn't up to her standards.

By the way, I got a great compliment from Farrell who told me he "was a much better shot when hunting over the red setter." That's high praise coming from a Springer owner!"

Thanks Tom! Sounds like you and Bailey are a perfect match— one that was meant to be from the very start! A tip of the hat to you for sharing your story— and speaking of hats, I'm sending you one for being our featured member this issue.

Interesting Dog Trivia


- ◆ President Franklin D. Roosevelt's most famous canine companion was his Scottish Terrier, Fala, who is part of the Roosevelt Memorial in Washington, D.C. But during Roosevelt's 12 years and one month as president, 11 dogs lived in the White House. They included a Bullmastiff, Two RED SETTERS, a retriever, a Bulldog, a Llewellin Setter, a Scotch Terrier, a Great Dane, a Sheepdog, and a German Shepherd who tried to rip the pants off the British Prime Minister. See historic photo on our back cover.
- ◆ The Canary Islands were not named for a bird called a canary. They were named after a breed of large dogs. The Latin name was Canariae insulae -"Island of Dogs."
- Dogs in monuments: The dog is placed at the feet of women in monuments to symbolise affection and fidelity, as a lion is placed at the feet of men to signify courage and magnanimity. Many of the Crusaders are represented with their feet on a dog, to show that they followed the standard of the Lord as faithfully as a dog follows the footsteps of his master.
- ◆ The common belief that dogs are color blind is false. Dogs can see color, but it is not as vivid a color scheme as we see. They distinguish between blue, yellow, and gray, but probably do not see red and green. This is much like our vision at twilight.
