pleasing gait. Both judges were hoping that she would point a bird and toward the end (at 25) she had a good find, spinning around and locking up beautifully. Great job.

Quail Acres Jake (littermate to Rose) had an exciting way of going with a great deal of speed, some nice casts but some were undone by his coming back. That was what separated the first and second place dogs. The races of the first two dogs were speedy with cracking tails and plenty of animation.

Third went to Nantucket, Irish setter owned and handled by Roger Boser, who is no stranger when it comes to the winners' circle. Nan's race was somewhat restricted in comparison to the first two, animated and responsive to Roger's commands. As is usual with Boser's charges she is a finished product when pointing, staunch and quiet on her stance. She had an unproductive and one nice find. All-in-all, the three are certainly potentially good shooting dogs.

This nice stake was judged by Charles Young and your scribe. Charles' qualifications are well known; mine not so much since I rarely judge, but have been trialing for 56 years.

These comments are from the judges of the Shooting Dog Stake. Breakstone, an Irish setter, set the standard in the first brace. Coming off a runner-up performance at the Region 3 Amateur Championship, it was as if he was still continuing his performance here. He was found on point at the ditch area after an extended absence but still within the

parameters allowed. Lofty on his points while on point and the bird's flight, he is a picture to behold. He concluded his performance with a great back. The bird flushed right over his head and nary a move from him. He finished going away. Tough to beat that kind of performance in the first brace. You now were vying for second and third.

Hasty's Hot Pepper took second with a strong race. Pepper had two shared finds and a strong race. Easy going gait and spirited can best describe Pepper's performance. Third place went to Rowdy which had a fast snappy run. Unfortunately somewhere along during the brace he came up lame but carried on and finished the course, albeit slowed down. His find was at the end of the ditch area in the open and hardly crowding the birds. He looked good on this his

only find. Backing him from a distance was the second Irish setter in the stake, Justified. A scene that is always great to see and what helps make the sport of field trialing why it is so absorbing for those involved in it.

Our thanks to Tim Ruff for judging this stake along with Dr. Jo Denton. Both men are known for their qualifications as judges.

Although our entries were down, we had a great time watching some very fine dogs.

The club wants to thank all who came and ran their dogs. It is hoped that our spring trial will not have the conflict of championships as we encountered this time. Looking forward to seeing all our usual friends next time.
