TO THE MEMBERS OF THE NATIONAL RED SETTER FIELD TRIAL CLUB

I am sure there was a lot of disappointment in the fall trial being canceled. I have received a number of letters with varying types of comments. In order to set the record clear I would like to state that I personally contacted all of the directors and the field trial chairman regarding the fall trial. Eyeryone was asked to poll his area and report all expected entries. A few days later the entries were as follows:

Puppy----4
Derby----4 to 5
Shooting Dog-8
Championship-8

It was felt there would be other entries but that the additional entries would not be sufficient to support a good trial. This decision was based purely on the lack of entries and nothing else. As you know we have had too many trials in the past with lack of entries. The Championship cannot be maintained with our present type of trial. Minimum standards must be established.

It is my hope that we can come up with a minimum standard requirement for a field trial that will be suitable. We are working on trying to have these standards put into effect before the spring trial.

Should the Santa Caligon Club feel that they would still like to have the trial in their area next fall these minimum standards will let them know exactly what is required so that a cancellation will not be necessary. The interest shown by the people in the mid-west as a result of canceling this trial is very encouraging and shows that if the members in that area will run their dogs, they can put on an excellent field trial.

You must Enter Your Dogs in order to have a field trial.
