#### FLASH! FLASH! FLASH! FLASH!

#### IRISH SETTER CLUB of MINNESOTA APPLYS FOR MEMBERSHIP IN AFTCA

One of the highlights at the annual dinner of the ISC of Minn., particularly for the field enthusiasts, was the unanimous approval of a motion that our club affiliate with the Amatuer Field Trial Clubs of America. If our application is accepted, the spring trial winners will be eligible for the coveted "Certificate of Win" issued by the A.F.T.C.A. to winners of recognized events.

The A.F.T.C.A. was incorporated in 1948 for the purpose of increasing the interest in restoration and conservation of upland game birds through the promotion of field trials. on this type of game bird. In addition to controlling advising regulating and conducting field trials, the organization has been active in all phases of upland game bird conservation. The by-laws and running rules are very similar to those of the American Field, and, insofar as our events are concerned, are exactly the same. Age limits for the various stakes will remain as before, as will the criteria for judging and evaluation of performance. The big difference between our next trial and those conducted in the past will be the "Certificate of Win" mentioned above. Miss Leslie Anderson of Hernando, Miss., the current secretary of the A.F.T.C.A., records all recognized events held by member clubs as well as the winners of these events. Any trial held by a member club which is run in accordance with the rules and regulations must report the names of winners to the secretary who then issues a certificate to the owners of those dogs placed in the recognized events. These certificates in turn entitle the winners to be entered in the various championship events sponsored either directly by the A.F.T.C.A. or indirectly through the member dues. An example of the former would be the National Amatuer Pheasant Championship, while an example of the latter would be a regional amatuer championship. The primary value of these certificates is, of course, the opportunity for the owner of a good dog to enter in a championship stake with the possibility of having his dog declared a field trial champion. This is a much more highly regarded field championship than those offered by the AKC for the simple reason that all entries in these events have qualified by merit and the competition is mighty tough. The AKC, on the other hand, grants championships to winners of recognized events on the basis of the number of dogs entered in the events won by the champion. This can and often does result in championships being awarded on a quantity rather than quality basis. The Certificate of Win is also valued for itself as it is a highly attractive memento suitable for framing. Heretofore the opportunity to participate in A.F.T.C.A. sponsored championship trials has been rather limited insofar

as upper midwest residents are concerned because of distance to the nearest trial. With the inaugral running of the Watertown, S.D. clubs classic, slated for this spring, area people will have a championship trial right next door. Additionally, benefits should accrue to all club members through increased support for our trials from veteran field trialers interested in winning a certificate.

Before closing it might be appropo to review the age limitations for recognized stakes. The puppy stake run between Jan. 1 and July 1 is for dogs whelped on or after Jan. 1 of the year preceeding. The same stake run between July 1 and Dec. 31 is for dogs whelped on or after June 1 of the year preceeding. Derby Stakes run between Jan. 1 and July 1 are for dogs whelped on or after Jan. 1 of 2 years preceeding, while the same stake run in the last half of the year would be for dogs whelped on or after Jan. 1 of the year preceeding. All-Age and Shooting dog stakes have no age limitation. Open Stakes are those in which there are no limitations on either dogs or handlers, while amatuer stakes are for amatuer handlers only.

All field people are looking forward to the spring season. This year should be a banner year with A.F.T.C.A. membership and a new field trial chairman to get things off in a grand manner. Don Wilson is well qualified and the only thing he needs to do an outstanding job is help from the committee and support from our club members. Let's all see that he gets them.

### The ISC of Minn. ANNUAL ALL POINTING BREED SPRING FIELD TRIAL Saturday April 28, 1962

Last year the club held its Spring Trial on April 8. This year, however, the snow looks like it may still be with us till the second weekend in April. With this in mind, Don Wilson called Crick Weather Central in Denver Colorado via WPBC radio in Minneapolis for the Crick Spring Forecast. It went as follows: more snow and cold through most of March with storms and extreme cold on the last week of March. Snow and cold was predicted to April 15. With Easter being the 22nd of April this year, the only possible "safe" weekend remaining was April 28 and 29th. The Northwest Field Association is holding their one-day trial on Sunday, April 29. This then left Saturday April 28th open, and Don Wilson announced it as our date.

Two AFTCA trials in one weekend may be just the incentive to bring both clubs many outside entries from Wisconsin, Iowa and South Dakota. It will be the first time our area has had two major club trials in one weekend.

The grounds for our trial will be at the Wild Wings of Oneka Game Farm near Hugo, Minnesota. Mr. Lyle Lerner, owner of Wild Wings, said this year he will have a club house on the trial grounds as well as 'His' and 'Her' facilities. Our refreshment girls headed by Hazel Wilson and Ruth Kremer should have a more pleasant time in a club house than in our tent.

Two other important items of the trial have been worked out. The horses have been obtained, and Mr. Lerner announced that the quail would be ready.

The stakes will be Open Puppy, Open Derby, and Open Gun Dog. The actual order of running will be announced later as will be the judges. If the entry becomes large enough, Puppy and Derby Stakes will be run on different courses at the same time, and will be under different judges. "Wild Wings" has ample grounds to run two consecutive contiguous courses.

Don Wilson is planning on a big entry. For this reason entry blanks are included in this issue of "Red Waggins". If you plan to run, or know of anyone planning to run, or know of a new dog owner who may be interested in trialing, make out an entry blank and send it to Don as soon as possible. This is important, as early entries will enable him to have some idea of the trial size. With this information he can obtain enough horses, judges, and have the actual grounds picked for each stake.

Entry fees need not accompany the entry blank, but will be due on trial day.

Tom Moffat, 4381 Forest Ave., Pontiac, Mich., is trial chairman. Headquarters in Delaware, Ohio. It is suggested that reservations be made as early as possible.

Judges have not yet been announced. There will be a handlers and members dinner Sat. evening at the completion of the day's running, but I don't have the location of this as yet. We will use the restaurant on the grounds for meals during the running, but Tom may elect to take the dinner back to the Campbell House, which has a new dining room as of last spring.
