It is the desire of the N.R.S.F.T.C. to give all Setter owners an opportunity to compete their dogs, so see others in action, and to place a Champion if he so qualifies.

I know of no better way to improve the breed in the field than by attending - participating and evaluating the performance of the other dogs that are there.

Seriously - why not plan on attending this Spring Trial on March 30 and 31st at the Hawfield Plantation? These are the grounds on which the Amateur Quail Championships and the National Open Shooting Dog Trial are conducted.

The area is more than ample, therefore we have contiguous courses and can accomodate that bitch even if in season by running her on a completly different course.

Your attention is called to several items, the most important being the closing date for entries: MARCH 15, 1968, so please be certain to have your entries mailed in time or place a hurried call, Tel. No. 201-459-4132. No post entries.

Horses are arranged for and your advise as to your needs should also be given to the F. T. Secretary, who will reserve one for you by the day, hour or brace. (Rates are \$15.00 day, \$3.00 hour, or \$1.50

Note that in Championship Stake you must fire a gun of 32 Calibre or larger. This is manditory in Championship stake, AFTCA rules.

Accomodations can be made at the President Madison Inn or at DeVivis Motel, both located in Orange, Va.

With the trial the most important, here is nowe from Jack --


"Bette Leigh and I went down to the Orange, Va. area to work pups at our trainer's and gleaned some news re, the Hawfield Trial concurrently.
