She had to be ridden for a couple of times due to deafness in one ear and impaired hearing in the other but it was clear she wanted to go with her handler, and she would reassume the front. The wetness and cold eventually slowed her to 300 yard casts in the last few minutes. No birds, but a memorable run on which to end a career.

Manteo's Duke (Turner) had the course to himself in the last brace. Untypical of Duke, his race was circumscribed. He spent the hour working bluff edges but his journeyman effort too went unrewarded by birds.


