

Plans are now complete according to trial chairman, Cliff Bean for our Spring Classic, April 9 and 10.

Judges for the Kildeer Plains area event will be Harry Evans and V. V. Van Divort. Some of you may recall Van from the September trial also at Killdeer in 1962.

Motel Reservations should be made if you haven't already at the Evergreen Motel, Upper Sandusky, O., to be with the creed. It also makes it handy for the drawing and dinner on Friday and Sat. at the Evergreen Restaurant.

Drawing time will be 9 p.m. All stakes to be drawn at this time. No post entries accepted in any stake. The club reserves the right to add other judges for the supporting stakes if the pressure of entries in the trial warrants or threatens the running time of the championship event. Announced judges will ride the championship and such other stakes as running time permits. Championship open of course to Irish setters only. One hour heats on contigious courses will be run with AFTCA winner's certificate to all stake winners if amateur handled.

Trial management reserves the right to limit entries to running time available. Not responsible for accidents during running of trial.

Fees are \$8 for Puppy and Derby stakes; Amateur Shooting Dog stake is \$12 and Championship is \$20.

You may mail entries to F. C. Bean on any entry form or wait until the drawing. Remember Upper Sandusky is located right at the junction of U. S. 23 and U. S. 30.
