CHAMPION IS DOUBLE JET

FLYTHE IS PRESIDENT

"Double Jet" was once again named Champion of the Spring Classic this year held March 25-26 at Kildeer Plains, Upper Sandusky, O. Judges asked by chairman, Cliff Bean, were Ted Stifel and V. V. VanDivort, both well known in the mid-west areas for their fairness in judging.

Double Jet is owned by Warren Johnson of Hopkins, Minn., and was no newcomer to the titled circle as she was also the champion of our April 10, 1966 trial at the same site. Her handling to top spot was in the capable hands of Ed Schnettler of Clear Lake, Minn., who spent the winter training and working with a fine string on the Pine Bluff, N. C. grounds. Double Jet was also this year's winner of the Duke Memorial trophy presented to Ed by outgoing president Cliff Bean who in turn gave it to Dr. Strand, official delegate for its safe return to Minnesota. This lovely bowl given by Lucy Jane Myers in memory of Fred Kremer has now been won by Mr. O'Leary, Schnet's Little Red and Double Jet, who had the most wins during 1966 in FDSB trials. Congratulations on both of the awards, Warren!

Other Championship contenders in this hour long Sunday stake were Autumn Hills Penny, owned by Dr. Charles Bloom, handled by Schnettler; Autumn Hills Count, owned by Jim Flythe, handled by Tom Moffat; Windyridge Tammy owned and handled by Cliff Bean; K.'s Darky, owned by new member Dr. D. Kelly and handled by Schnettler; and Miller's Tiger Lily, owned by Bean & Dr. Paul Miller, handled by Bean.

AMATEUR SHOOTING DOG STAKE winner was Windyridge Tammy. Marilyn and Cliff Bean's consistent winner showed wonderful stamina and style on Sat. but just wasn't up to an hour long race Sunday having been operated on this winter while wintering in Florida. First place was not new to her either having been first in '66 also in this stake. Tammy was also second in the fall; third in '65 and third in the spring and fall of '64. She was whelped July 1, 1957 and is by Ike Jack Kendrick ex. Van's Cindy.

Second place went to Schnet's Little Red and is owned by Jim Flythe. This male is the much photographed member of the Flythe string often posed with red, white and blue hat and blanket and this year with Judge Robert Coleman's pipe but in spite of this frequent display is a fine bird dog! Third spot was won by Miller's Tiger Lily handled by Bean while her other owner basked in the Florida sun. He sent fine envoys though and we did enjoy the company of his son-in-law and daughter, Terry and Anne Unsworth of Lansing as well as Terry's services as part-time marshall. Lil is by Sulhamstead Norse D'Or ex. Miller's Bonnie Loo.

Other shooting dog entries included Autumn Hills Count; Dan, owned by Dr. Roger Strand of Minneapolis; Dan, owned by Bill Cargo of Chilicothe, O.; Double Jet; and North State O'Brady, owned by C. T. Taylor and was handled by new member E. D. Nelson of Hickory, N. C.

DERBY STAKE winner was County Clare's Country Squire owned by Ernie Lewis of Pacific Palisades, Calif., and handled by Stan Head of SanMateo, Calif. Squire was whelped Oct. 11, 1965 by dam County Clare's Mighty Fawn and was sired by Valli Hi Country. His litter mate, County Clare's Country Lad placed second so it looks like Mr. Lewis and Dave Hasinger brought a good combination together! Third placement went to Back Lick Red owned and handled by Dr. Roger Boser. Red is ex. The Cribber by Sulhamstead Norse D 'Or (Shane really has some good ones in here!) and was whelped Jan. 1, 1966. Bosers are of Falls Church, Va. for April anyway as they will soon be moving, again! Others trying for a winning berth were Lee owned by Dr. Miller and handled by Unsworth; Sat. Night Ed, Flythe; Snowstorm Rachel, Flythe (like to keep couples together); Schnet's Jenny K, Schnettler; Windyridge Kigme, Bean; County Clare's Toby, Lewis, owner & Head, Handler; Deerfield's Sean O'Ryan, Pat Ryan of Granite City, Ill., owner with Schnettler, handling.

PUPPY STAKE first was taken by Deidre of the Lodge owned by Frank A. Glynn of New Berlin, Wis. She is by Miller's Lad O'Lil out of Emerald Isle Angel, whelped Feb. 5, 1966. Again we have litter mates who on given days may beat the other out for a spot for Judy of the Lodge was number two at this trial. Third went to Dr. Boser's Back Lick Red proving his worth in two stakes. Making trys for placement were also Lynn, Miller-Unsworth; Midget, Flythe; Lee, Miller-Unsworth; Schnet's Festus, Flament, owner & Schnettler, Handler; Bridey's Norse D'Or, Ryan, owner & Schnettler, h. Dr. Mickey Bean, Marj. Moffat, owner, Tom handling.

Some fine work was shown, commented the judges, with some particularly good young red ones coming. A complete write-up of the running will be in The American Field, written by Judge Van Divort but I felt I had waited long enough for it to come to give you his report here. Ted Stifel had judged for us several years ago at the Delaware Dam area and said he could see big improvement over what we were then running.

We had the smallest trial since the last held at Dover, Del., when some of you remember Ned LeGrande calling his wife, Helen and the children to bring more dogs even if they each had to hold one on their lap. But it was a quality trial we thought with outstanding work, and trophies that trophy chairman, Ed Schnettler selected. The fine new LeGrande Shooting Dog bowl donated by the Hasingers and the Duke awarding, all helped to make a worth while event with many of our newer members attending like the Richard Harrells of Indianapolis, Gene Nelson and the Frank Neilsons now of Lakewood, O., who re-joined.

Friday evening the drawing was held at the Evergreen Rest., and the dinner and business meeting with election of officers was there Sat. evening. Pres. Bean called the meeting to order at 10 p.m. at which time the awards were made, reports given and a discussion of suitable grounds held. Henry Taylor is making arrangements for the fall trial

to be on the LeRoy, Kansas grounds. Stan Head commented on the poor ground conditions here and the lack of improvements of them. Suggestions for moving the spring trial followed with Hawfield, Pine Hill and Kentucky being discussed. Marilyn Bean moved that the problem be turned over to the directors. Motion was seconded by Jim Flythe and passed. Further business dealt with the Associated Bird Dogs Club of Ohio of which we were members. Our dues are paid for this year and it has been pointed out by Cliff Bean that if we lose a date here it would be most difficult to regain one since there is a trial every weekend. Also to be considered is the fact that the state is going to match birds (pheasants) from now on on a 50/50 basis.

With the opening of the meeting for election of officers, Dr. Strand presented the slate of Jim Flythe, president; Tom Moffat, vice-pres., and Marj. Moffat, sec-treas. Judge Coleman made motion nominations be closed and slate accepted. Terry Unsworth seconded the motion and the members approved unanimously. Judge Coleman then made an acceptance speech for Jum but it was in reality a chamber of commerce welcome to come to Kentucky and lets push the red ones more in Amateur trials around the country!

President Jim then suggested that a pamphlet promoting club and its efforts with more breeding publicity, etc., be made up for distribution to those we know have Irish but are not members as yet. Gene Nelson thought sketches on trialing and help with other's dogs with Whip relayed more to various members and areas for part of work would be good. Meeting then adjourned.

Other new members to be welcomed into the club are Gerald Ingraham, 403-76th St., Franksville, Wisc., and Roy Sisler, 128 7th St., Mather Pa.

Many others of the club as well as the club are mentioned, of course. See for yourself, why don't you? You'll find many of your show friends within its cover as well.

From the Sunday Herald Leader of Lexington, Ky., a column by Virgil Pryor proved a fine boost for the Red Ones. Mr. and Mrs. J. R. Lewis it seems some 20 years ago gave his family a big, rangy Irish that was quite a rascal but now after an outing with the new Irish over a 360 shooting preserve he fell in love with one called Shawn who showed class, that would grace any field trial, desire and steadiness to wing and shot, along with five others they worked to his satisfaction. So he admits things have been happening with the Irish all for the good!

Minnesota is having their spring field trial at Rosemount the 8th & 9th under the leadership of Warren Johnson which we'll report on too next month along with such things as this new year's Duke accounting! Our thanks to Dave Hasinger for sending the following: Stan Head expects to fly East with three of Ernie Lewis' Irish Setters to compete in the outstanding trial of the East, the English Setters Spring Field Trial program over Briardale Plantation, Estell Manor, N. J. commencing April 22. Six contiguous courses; abundance of native quail on all courses and they have stable and kennel accommodations on the grounds. It also has a guaranteed \$3,500 in the Briardale Free-For-All and a \$1,000 guarantee in the Open Shooting Dog Stake! (Ed.'s note, "How about that!") Mr. George Rogers, sec., would like to extend a special invitation to all Irish Setter fanciers to attend this trial and see Mr. Lewis' dogs as well as Valli Hi Country competing with America's greatest pointers. Entries to date include pointers "Riggins White Knight" and "Satilla Virginia Lady". This program to commence on Sat., April 22 and continue most of the following week, is a bit unusual in scope, purses and bird dogs of national reputation which it is attracting. Briardale Plantation has been carved out of southern New Jersey blackjacks and pines over a ten year period by Mr. Imbesi. It has been his plan to develop a replica of the quail shooting plantations in the deep south around Thomasville and Albany, Ga., and Union Springs, Alabama. In addition to the work done by Mr. Imbesi on field trial courses, he has developed a very successful thorough-bred breeding farm. He now has roughly 110-120 stallions, mares, colts, fillies and yearlings, including the incomparable "Tasmah." (Directors att: shouldn't I go?)
