This year's trial started on Friday afternoon with Nemaha Taxi topping the Derby for owner Dr. Pat McInteer. Second was Lamppost Mindy Lou with one find for owner Gary Collins. Richard Lewis put down Bocomo Cowgirl Up; she was named third with a good race. Judges for the Derby and the Scott Wilnerd Classic were Marvin McDowell and Gordon Hazlewood.

The Scott Wilnerd Shooting Dog Classic drew 20 hopefuls from Arizona, Missouri, Nebraska and Kansas. The winner came from Missouri in the name of Westfall's Red Line, pointer female owned and handled by Richard Lewis. She ran the second hour course on Sunday morning with a snappy up front race and one nice find. The runner-up came from Kansas in the form of Aiken, Irish setter male owned and handled by Don Beauchamp. Aiken ran the third hour course on Friday afternoon with two good finds.

Judging this year's Championship and Derby were Don Duckworth of Morganfield, Ky., and Harry Gillmore of Murphysboro, Ill.

In the Open Derby, first was Bocomo Cowgirl Up (Richard Lewis) with a good performance on the front end. Second was Hailey's High Dollar (Jerry Hailey). Placed third was Spider Back Rip (Dean Lord). All Derbies were placed on race in very warm and windy conditions.

This year's Sunflower Championship winner was Fearless Little Bit, pointer female owned by Carol Fox of Licking, Mo., and handled by Marvin McDowell. Bit ran Wednesday morning with a strong up front race, one unproductive just past the flat pond. At times she was not seen by the judges, then at 63 point was called by Marvin along the east fence before the corrals, a wild covey all in order. Kaw Valley Sam was named runner-up. Owner Robert VanLerberg of Shawnee, Kan., was on hand to scout and help McDowell with his dog.
