Rotating trophys and permanent for Championship, and first place. Permanent trophy for runner-up (if there is one) and second and third placements.

The new Shooting Dog Rotation award presented by Mr. and Mrs. David Hasinger is called "LeGrande Spring Classic" and must be won three times for permanent possession. It is a lovely silver bowl and ready for an addition to its engraving! Why not try and have your dog's name there?

Last spring's Championship winner was Double Jet to whom full title was given. Now this spring she is to receive another award for she is the winner of the DUKE MEMORIAL TROPHY! This will be presented on Sat. evening to her owner or his delegate, Warren Johnson of Hopkins, Minn. This trophy was donated by Lucy Jane Myers, owner of Draherin Irish Setters of Duluth, and in honor of the late Fred Kremer and all of the wonderful things he did for our field Irish. First winner of it was Ch. Mr. O'Leary, owned by Cliff Bean and second winner was Little Red owned by Jim Flythe. It is given, along with a permanent smaller silver bowl, to the dog gaining the most points in Am Field recognized trials during the year, running March to March.

Double Jet was sired by Double Jack ex. of Lady's Colleen. Lucy Jane Myers has just written recently that Lady's Colleen had a stroke Christmas Eve and had to be put to sleep Dec. 27th. She would have been 13 in Jan. She too was quite a lady with a host of memories for many of us having many wins of her own afield while still with Ned LeGrande and the dam of Ch. Lady's Queen, Brun's Rusty Hobo, Double Cross, Moffat's Apache Bill as well as Ch. Double Jet. Due to so much to do Lucy Jane has placed her remaining field stock with Al Soutar who has so capably handled Draherin Lord Kendrick.

Getting back to Jet she won at our trial in April as well as Northwest Field Trial Assoc. where she was 2nd in Open Shooting Dog. This was an all breed win with the two wins totaling 190 points. In March of '66 she was 1st in the Am Sh. Dog all breed of the Blue Grass Field Trial Club, thus adding 115 and in Oct. she proved it to them again at the same Club trial by taking 1st in the Open shooting dog with 80 more points added making her total 385! Nice going!

Timmy's Baby Bean, owned by Bob Harrison of Gardner, Kansas gave Jet a good run and push with a 314 total. Sire is Candy's Tim O'Day and the dam is Ginger of Spegaldale. Wins were as follows: March '66 ist Am. Sh. Dog at S. E. Kansas F. T. C. all breed (80); April NRSFTC Ch. runner-up (72); also April 3rd in Open Shtg. Dog at Santa Caligon ISC (30); 1st in Irish Open Sh. Dog same trial (50); 1st in Open Sh. Dog (all brd) Santa Caligon in Nov. (55) and N. E. Kansas FTC in Nov. 3rd in Am. Sh. (27).

Taylor's Whirlaway Chief owned by Mary Taylor and handled by Henry was next in the line-up with 5 good wins. Sire is Taylor's Whirlaway Pat and dam is Double Jack's Rose.

Chief's wins include 2nd in Open All Age at Santa Caligon Mar. '65; 3rd All Age at N. Mo. F. T. Assoc. Sept.; 1st Am All Age at Sunflower State FTC in Oct.; 2nd in All Age at Santa Caligon in Oct.; and 2nd in the Nov. Santa Caligon Open Sh. Dog stake.

Vanita's Wild Gael owned by Dr. and Mrs. J. S. Van Wye of Kansas City was next in the line up and is by Mr. O'Leary exx Tara O'Shadycrest. Her wins include 2nd in the Open Sh. Dog at Santa Caligon April trial; 1st in the Open Derby for Irish only as was the above and second in the All breed Sh. Dog. A busy little gal! Her others were Husker Neb. April event were she had a 3rd in the all breed Sh. Dog; 3rd in Nov. Santa Caligon and in both the Sht. Dog Open and Irish only.

Autumn Hills Penny owned by Dr. C. H. Bloom of Minneapolis had three nice wins two of which were in open stakes. Ed Schnettler, handled. Her sire: Autumn Hills Frank and Dam: Autumn Hills Maggie.
