The professional trainers who entered dogs were Mike and Jeanette Tracy and Dominic Preite. The Tracys, who had

The field trial required three days and it took help from many people, including: Ted Matison, Bob Mamounis, Dom Preite, Howard Miller and Mike Archer.

The open horseback stakes were run on Friday. In the first brace of the Open Shooting Dog, Jeanette Tracy's Bay Country Hope ran powerfully with one find which she handled well to take third. Mike Tracy ran Coosawhatchie Chief in the 7th brace. Chief didn't seem to mind the heat, finding three birds and running a very pretty race. Mike came back in the last brace with Our Big Bully which seemed unaffected by the heat, ran a classy race, handled easily and had three straight-up finds for first.

Although most of the Derbies were

On both the bracemate chased her birds but she remained steady to wing and shot. Bullerina, second, ran a very pretty ground race and handled easily. She had two finds; on one she was broke, on the other she took several hops when she bumped the birds when she was relocating. The Thrill is Gone did very nice work on the ground and pointed one bird where she was steady to wing and shot.

The amateur horseback stakes were run on Saturday. The day repeated itself with a cool start leading to a very hot day. The first brace started at 7:30 a.m., Merv Eisenhart running Maple Valley Cowboy which ran a real nice race and had three nice finds. Breakstone, in the second brace, also had a really nice race. Breakstone had a find, a divided find and a back to win the red ribbon. Finding birds became scarce until Annabull ran in the heat of the 9th brace. She dug up three finds and had a good race, undaunted by the heat. She had an unproductive find at the end and won third.

In the Amateur Derby, James Heimdal won the blue ribbon with Klee's Buster which had a classy race and one find handled even though there was confusion with his bracemate. Second was Justified which had a good find and a good race.

In the Walking Shooting Dog Stake, Check Point Steeler had three stylish finds and an unproductive. Mohawk's Thundercat also had three finds and an unproductive. "Gail" ran a good race too. War Standard, third, hunted very hard and far and had one good find.

The Amateur Derby had four dogs and first went to Dew Sweeper which hit the cover and scored three times on

birds. The Amateur Puppy also had four dogs entered. The winner was White Pine Twist which ran an exciting race.

All in all it was a great weekend. Hopefully this will be a field trial that can become an annual event.
