Here is the Spring Trial Report that you have been looking for as written by chairman, Jack Ullrich

Toccata, six year old Irish Setter bitch emerged the winner of The National Red Setter Championship at "Hawfield" near Orange, Vac., on March 30 and 31, 1968.

The members of the National Red Setter Field Trial Club were fortunate to run over this famous venue, and they are deeply in the debt of R. H. Cross, Jr., The Virginia Game & Inland Fisheries Commission, and especially to Stuart B. and Guy H. Lewis III.

Dick Brinkley ably marshalled with Stuart Lewis. Especially appreciated was his gate opening style.

The weather was sunny, warm, and breezy both days. There was a little rain the eve of running, but its benefits were quickly dispelled during the first couple of braces by the sun & wind. Mostly it was hot, dry, and dusty. Birds were ridden up by the gallery with regularity; some were singles indicating that they were beginning to pair off.

The Champion & Others

The new titleholder, Toccata, is by Jimmy K ex. Nita Jo by Mr. Mack Tripett so she comes by her abilities naturally. Kathy has a deceptively effortless, ground consuming, way of going. Her gait never slowed during her hour, even with temperatures in the eighties Handling kindly, she finished as she had begun; each time her feet hit the ground her tail cracked with gusto; her swings, particularly one at about 50, were wide and full of purpose. Toccata's efforts were rewarded with one find at about 40. Under trying conditions one bird was produced to her point some 30 ft. over bluff edge above the bowling alley. She stayed nicely for the shot. This writer is happy to own and handle her and is grateful to Elgin H. Niningger of Trevillians, Va. for her development.

April Whip-2-

The runner-up spot was amply filled by Valli Hi Country in the string of Stanley Head of San Mateo, Calif. He is owned by E. J. Lew. of Pacific Palisades, Calif., and David Hasinger of Philadelphia. Down in the first hour his race was adequate to dig up a well-handled covey near old slave cemetery and have a stop-to-flush on a covey feeding by cornfield near Mountain Run. Peet's Contention (Dave Peet) & Autumn Hills Penny (Dr. Bloom) rendered class races in their hours but found no birds.

Open Derby

Goldleaf Mr. G. and Backlick Red the first & second place dogs met in the second brace. Their casts through the bowling alley were prodigious enough so that the marshalls reported extending their course to accomodate them. This fleet pair did it on class. Other braces of derbies required shortened courses to made the dog wagon on time. In third place was Emerald Isle Lad (Frank Glynn) who used heels to better the rest of the field.

Open Puppy

Clancy O'Ryan used his 20 minutes to show us just how a really classy puppy looks. He showed merrily at the edges with a sophistication that belied his age. (I beleave this is Pat Ryan's) He knocked a few birds puppy-style and made a nice cast along Mountain Run. Turkey Talk Chip (Jim Flythe) showed plenty of go and was attractive moving. Amateur Shooting Dog

This stake was run over one, hot, dry, liberated-bird course. Ample birds were released but finds were sparse. Scenting conditions, as we humans surmise, were probably poor. Schnet's Little Red had one well-handled find and a level effort. Autumn Hills Count spent considerable time out of ken, and when returned to the front had let down. (both Flythe dogs) Count had one clean find and another in thicket who bird refused to fly. Due to scarcity of birdwork a second series was called for third place which was soon filled by Lindell's Red Dawn on the strength of one find.
